 - University hired Aldon & Associates to review athletics on campus. Aldon & Associates recommended
 it would be too expensive to move to Division II and the University should remain D1 for the next 5
 vears.
 - Run4Scholarships in 2015 raised \$47,000.
 - Asher Agency helped do some of the studying of rebranding. Athletics has been rebranded to Fort Wayne. This move was made in an attempt to help people outside the region recognize IPFW.
