- Call to Order / Questions about Minutes LV: Started the meeting at 1:12. Members present: LV McAllister, Beth Iserman, Allyson Schreiber, Bruce Arnold, Kayla Klimasko, Karen Burtnette, Julie Creek. Members absent: Cassandra Bracht, Alison Rynearson, Amanda Seilheimer, Steve George, Kim Myers.
- 2. Presidential Update LV: We are working on marketing right now. Invite from Melissa Helmsing to meet next Tuesday (Kayla, Bruce, LV, Amanda, and CSSAC members). APSAC would like independent funding but is happy to be a part of joint efforts with CSSAC. Purdue Global will have free tuition for Purdue employees. IPFW bursar's office does not have data on this. Tentatively, employees, spouses and all children under 26 years of age, will receive 100% tuition free (associates, bachelors, masters, no PhD) memo with more details is coming out soon. There could be a waiver for professional experience. We can apply by April 2, 2018. Get your transcripts in order. Financial aid will be the same. Books, fees, etc, are still expenses but tuition is free. Transfer credit from Purdue or IU credits will most likely transfer over very nicely.
