- Director of Public Relations, Kim Wagner attended our meeting as well as members of the CSSAC steering
 committee. The group gathered questions for Kim regarding the University realignment, University
 communication plan, rumors heard on campus, etc. Kim confirmed that in regards to campus
 communication, her office would send out announcements to the campus community before sending to the
 media. She also confirmed that at this time, the campus is keeping our current colors and mascot.
- Health Fair Updates, Carrie Romines- Carrie met with our group to discuss the upcoming Health Fair on March 22, 2017 from 9am-3pm in Walb Student Union.
