# MINUTES OF THE MEETING OF JANUARY 20, 2005

Walt Branson called the sixty-sixth meeting of the Committee to order at 9 A.M. in ET 206.

Approval of Minutes	Minutes from the December 16 meeting were approved.
Report on my.IPFW portal	Bob Kostrubanic distributed graphs showing usage of the new portal. About two-thirds of registered students have used the portal, even before conversion of the OASIS system to require access via the portal. The OASIS system change is scheduled to take place in February. Electronic payments represent about one-half of the usage. Pay-by-mail is declining in usage.
Hosting Web Sites for other Organizations	Bob Kostrubanic distributed a suggested policy statement, and ITPC members suggested several amendments. Walt Branson, Edna Neal, and Judie Violette will amend the Web policy approved by ITPC to incorporate this topic.

Expanding Group Workstations in the Library

Judie Violette recommended expanding the number of group workstations in the library since they have proven to be popular and well-used. Public workstations on the second floor would be replaced, while the public workstations on the first floor would remain. The request will be considered during preparation of the student technology fee budget for 05-06.

Initial Screen in Student Access Laboratories Judie Violette proposed that the current IT Services initial screen be replaced with the my.IPFW portal screen. The change will be made.

# **Other Updates**

## Conversion to the new IPFW Web site

Judie Violette distributed a status report on the conversion project. The report will also be posted and updated on the new site as a way to keep everyone informed about progress on the project.

## Possible music download service provider

Bob Kostrubanic reported that discussions are taking place with a music download provider. Purchasing has signed a contract, which includes the vendor providing a server, student payments to use the service at various levels. Student government is considering whether to provide funding for a group purchase.

## Wireless access policy

Bob Kostrubanic reported that a wireless access policy will be proposed at the next ITPC meeting. The proposal will address the problem with conflicting addressing schemes used by individually-installed wireless access points.

## Neff Open Access Lab Size Increases

Bob Kostrubanic reported that the NF B27 and B29 have both been increased to 22 stations in order to accommodate additional classes.

## **Database Services for Faculty**

Bob Kostrubanic reported that development of databases for faculty has been growing. Future systems will be developed in Oracle whenever possible, and use of MS Access will be discouraged.

## Data Services at the Dolnick Center

Bob Kostrubanic reported that the project to provide data service to Dolnick has been completed.

## Recent E-Mail problems

Bob Kostrubanic reported that the recent e-mail system reliability problems were related to a software upgrade. The problems seem to have been resolved.

# KT South Wing Re-wiring

Bob Kostrubanic reported that the KT South wing re-wiring project is expected to be completed by the end of January.
