| <b>Approval of Minutes</b>                   | Minutes from the January 18 meeting were corrected and approved.  |
| <b>Report on Printer Support</b>             | Bob Kostrubanic presented results of a study of current support arrangements for various kinds of printers on campus, concluding with a recommendation to stay with current arrangements. ITServices is not serving as a repair option but is referring offices to outside service providers. The original problem has also become less severe. Offices with 'group B' printers will also be encouraged to consider maintenance contracts. The group agreed that there should be no central funds set aside for this. |
| <b>Update from the Portal Research Group</b> | Bart Tyner and Barbra Mullinax presented a plan called MyIPFW and will be looking closely at the system used at Buffalo. A report will be presented at the next ITPC meeting. Susan Hannah distributed a conference report from the Provosts on Portals group and asked that she be included in the group reviewing plans for an IPFW portal.   |
| <b>SCT Integrator and WebCT</b>              | The timetable has been accelerated and now includes plans to connect WebCT to the Plus2000 product this fall. The system will then be part of the migration to Banner.  |
| <b>Limits on Printing</b>                    | Bob Kostrubanic reported that there is no viable arrangement for limiting printing. IU uses custom software. The problem is also not as serious as when the study group first started investigating the issue.  |
| <b>VIC Upgrade</b>                           | Verizon has offered a contract price of about \$ 87,000 for a DS3 connection, and this approach would address issues with the VIC system as well as overall capacity for the campus Internet connection. The system would also be capable of supporting an Internet2 connection. Work will now begin on identifying continuing funding for the service.   |

**Other Items**

Bob Kostrubanic reported that there have been complaints about slow modem service, and the problem could be addressed by installing a new modem bank for about \$10,000. The group did not endorse upgrading the system.

Bob Kostrubanic also reported that Napster files are interfering with other campus Internet service and asked for approval of efforts to limit "outgoing traffic." The group approved blocking of outgoing Napster and similar files. A report on the impact of this change will be presented to ITPC.

Bob Kostrubanic also reported on usage of the KT computer labs on Saturdays. Service in KT, NF, and WU is being considered in terms of costs. No immediate changes are planned, and a report will be prepared for ITPC.
