

Subject: Amendment to Fort Wayne Senate Document SD 83-9, "Policies Regarding Continuing Education . . ." (also modifies the understandings in Senate Reference No. SR 85-2, "Guidelines for the Operation of the Office of Continuing Education")

I believe the following "Proposed" wording is that of the Continuing Education Advisory Subcommittee with changes recommended by the Educational Policy Committee in the September 26 EPC meeting.

Resolved, That Sections A.8.b.1-2, of Fort Wayne Senate Document SD 83-9 be amended as shown below.

A.8.b. The SAU [sponsoring academic unit] shall be credited with incentive funds of:

A.8.b. The SAU shall be credited with incentive funds of:

1. twenty percent of the net income from those courses in which academic departments/divisions have played a substantial role. "Substantial" shall include but not be limited to the following: assisting in course institution and/or development; identifying and/or providing qualified instructors; using departmental/divisional resources; or
2. five percent of the net income from those courses in which the SAU has played only a minimal role. "Minimal" shall include agreement to serve as an SAU. SAUs shall review course content and instructor credentials.

1. fifty percent of the net income from those courses in which the SAU plays a substantial role. "Substantial" shall include but not be limited to the following: initiating and effecting course development; providing or identifying and certifying qualified instructors; and providing the major resources to publicize and support the course; or
2. twenty percent of the net income from those courses in which the SAU plays a moderate role. "Moderate" shall include but not be limited to the following: assisting in course institution and/or development; supplying full-time faculty from the SAU as principal instructor(s), or otherwise providing or identifying and certifying qualified instructors; and providing some departmental/divisional resources to publicize and support the course; or
3. five percent of the net income from those courses in which the SAU plays only a minimal role. "Minimal" shall include agreement to serve as the SAU and to review course content and instructor credentials.
