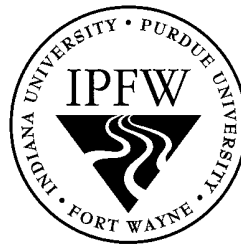

Clio is an international journal and the only English-language triennial that deals with three interrelated topics:

- literature as informed by historical understandings,
- historical writings considered as literature, and
- philosophy of history, speculative and analytic.

Articles appearing in this journal are abstracted and indexed in *Sociological Abstracts*, *Abstracts of English Studies*, *Humanities Index*, *Annual Bibliography of English Language and Literature*, and *ABC-Clio*. Electronic index and abstract databases are available from EBSCO publishing. The contents of *Clio* are reproduced in various EBSCO databases as well.

Manuscripts should follow *The Chicago Manual of Style*, 15th edition (with footnotes kept to a minimum). Electronic submissions only, acceptable file formats are Word (.doc or docx) or Rich Text Format (.rtf). Please send submissions to clio@ipfw.edu and include complete contact information and preferred email address.

To facilitate blind peer review, the author's name and affiliation should not appear on the manuscripts; instead, attach a cover sheet with appropriate information.

Clio is published three times per year. Annual U.S. subscriptions for individuals cost \$40 and \$15 each for back orders. For U.S. libraries and institutions, subscriptions are \$90 per year and back issues \$30 each. International subscriptions rates are \$55 for individuals and \$105 for institutions, back issues are \$22 and \$40 respectively. All payments must be made in U.S. dollars.
