

PURDUE FORT WAYNE STUDENT HOUSING

UPDATED POLICIES

TO ENSURE THE SAFETY OF OUR CAMPUS COMMUNITY, WE ARE IMPLEMENTING THE FOLLOWING POLICY CHANGES. POLICIES ARE SUBJECT TO REVISION BASED ON CDC OR INSTITUTIONAL GUIDELINES TO ENSURE COMMUNITY SAFETY.

COVID RESPONSE

- Masks are required in all campus buildings or within 6 feet of another person, including during move in and desk interactions
- Residents and guests will be expected to follow social distancing when possible, including in line formations. Staff may ask individuals to leave an area if appropriate Covid-19 policies are not (or cannot be) maintained.
- Residents will be asked to disinfect shared items, such as carts, before returning.
- If residents or guests are symptomatic or have been exposed to Covid-19, they will be asked not to come until they have quarantined appropriately. Accommodations for quarantine may be provided on a case by case basis.

HEALTH INSPECTIONS

- Health Inspections will take place quarterly (August, November, February and April) by a team of university staff.
- Inspections will be thorough, checking every space in unit and opening cabinets, refrigerators, closets, etc.
- Maintenance needs such as filters will be addressed at these times.
- Radiological and Environmental Management will be ensuring hygienic living spaces and assessing any health issues.

GUEST POLICY

- During Move In (Aug. 19 - 21) only 2 guests are permitted per resident. Guests must be 16 years of age or older.
- Non-Residents will not be permitted from Aug. 22 - Sept. 7.
- After Sept. 8, residents will be permitted one guest at a time, with no overnight stays. Guests must follow Housing policies.
- Residents are permitted to visit other resident units, with limits on the total occupancy of each unit. No more than 10 individuals in a 4 bedroom unit, no more than 6 in a 2 bedroom unit, and no more than 3 in a 1 bedroom unit.

COMMON AREAS

- Elevators will be limited to a one person occupancy at all times. Stairwell use is encouraged, and each will be assigned a direction to maintain traffic flow.
- Building lounges and labs will be closed for move in. Restrictions apply during the academic year.
- Laundry rooms will be limited to no more than two people at a time
- Drinking fountains will be closed until further notice.
- The Clubhouse will be assigned a traffic flow. Tours will not take place until further notice. Students will not be permitted behind the desk or in back offices. Guests will not be permitted in the Clubhouse unless for programming.
