RE: Code for Grade Not Submitted

WHEREAS, under the current system if a grade has not been submitted by the grade entry deadline the course enrollment does not appear on the student record; and

WHEREAS, courses for which grades are not received until the end of a term such as in the school based program are not listed in the student record until the grade is received and processed; and

WHEREAS, this omission leads to confusion for students and advisors who do not know the grade was not submitted; and

WHEREAS, this confusion could be reduced if it were communicated to a student that a final grade has not been received or processed;

BE IT RESOLVED, that the Registrar will enter a placeholder code of NS, for Grade Not Submitted, to all enrollments when the grade entry deadline is missed or to reflect the status of a grade which will be received after the end of the term (for example, school based program grades). Any course with the NS placeholder is omitted from GPA computation. The NS is replaced by a submitted grade. This change will be effective beginning Spring 2014.

WHEREAS: "Purdue University is committed to maintaining a community which

recognizes and values the inherent worth and dignity of every person; fosters tolerance, sensitivity, understanding, and mutual respect among its members; and encourages each individual to strive to reach his or her own potential. In pursuit of its goal of academic excellence, the University seeks to develop and nurture diversity. The University believes that diversity among its many members strengthens the institution, stimulates creativity,

promotes the exchange of ideas, and enriches campus life;"* and

WHEREAS: "Purdue University does not condone and will not tolerate

discrimination against any individual on the basis of ... sexual orientation, gender identity or gender expression;"* and

WHEREAS: Purdue University has extended benefits to same-sex domestic

partners of University employees and their eligible children since

2003; and

WHEREAS: The amendment to Article 1 of the Indiana Constitution concerning

marriage (referred to as HJR-6) is contrary to the values and policies of Purdue University and will harm employee recruitment

and retention.

THEREFORE, BE IT RESOLVED THAT:

The Purdue University Senate opposes the Indiana State Constitutional amendment concerning marriage (HJR-6) and therefore strongly urges the Indiana General Assembly and the Governor of Indiana to oppose adoption of HJR-6.

Rationale for The Purdue University Senate Expresses Public Opposition to the Amendment to the Indiana Constitution Concerning Marriage (HJR-6)

The Indiana General Assembly is projected to be in session before the January meeting of the Purdue University Senate and will be confronting HJR-6 early. If the sentiment of the Purdue University Senate is to be heard, it must be at our November 18, 2013 meeting.

It is the second sentence of the amendment that is relevant to the benefits offered to employees at Purdue University.

Text of the proposed amendment to the Indiana Constitution:

"Only a marriage between one (1) man and one (1) woman shall be valid or recognized as a marriage in Indiana. A legal status identical or substantially similar to that of marriage for unmarried individuals shall not be valid or recognized."

What institutional research, if any, has been done to determine the specific reasons why so many IPFW students do not take 15 credit hours per semester or graduate in 4-6 years? We have all heard the generic reasons that our students have jobs, families, and "busy lives," but have we investigated the specific dynamics at work (e.g., number of students with excess credits and attempted hours upon graduation and the causes of those excess credits and attempted hours; average number of hours worked and the impact these hours have on student performance; performance of full-time vs. part-time students, in terms of GPA, graduation rates, time-to-graduation; student-advisor contact vs. semesters to graduation, etc.) in order to help us devise and enact more targeted reforms, assistance programs, or information campaigns?
