W. Unsell presented SR No. 91-16 (Items under Consideration by Senate Committees and Subcommittees) for information only. He explained that the Agenda Committee is now asking Senate Committee and Subcommittee chairs to list items under discussion in committees, as opposed to only items that are apt to come before the Senate as documents for consideration.

9. The general good and welfare of the University:

S. Hollander: Some comments on the air in the Liberal Arts Building--

Four years ago, due to concerns about air quality in campus buildings--especially the Liberal Arts Building--industrial hygienists from Purdue University at West Lafayette made a site visit to IPFW. They measured carbon-dioxide (CO₂) concentrations and supplied an extensive bibliography showing these to be a valid measure of general indoor air pollution.

The Purdue University team said 600 parts per million is the upper acceptable limit for C02; above 600 parts per million, they said, air would both feel stale and be medically unacceptable.

They found that CO_2 concentrations in CM varied between 850 and 1100 parts per million. The only exceptions occurred on the third floor, where the medical-education program enjoys a separate ventilation system.

Complaints about air quality in CM continued. When recently they reached a crescendo and serious health problems became evident, the Purdue team was invited back. Four years after their initial visit, they found that indoor air pollution in CM had <u>increased</u>: In 1988, CO₂ had peaked at 1100 parts per million; last mouth, it ranged up to 1350.

In 1988, the team made two major recommendations. The first was that smokers be isolated from other CM occupants, and this was done. The second was that the amount of outside air being brought into the building be substantially increased to reduce pollution caused by heavy occupancy in this "energy efficient" structure. Nothing appears to have been done toward this end.

In its most recent report, the West Lafayette team again recommended that ventilation-outside air--be substantially increased. The inspectors also noted, for the first time, problems "with the outside air screens being plugged with debris and general maintenance of the units."

IPFW Physical Plant personnel seem finally to be concerned about these problems--at least to the point of planning to experiment with increased outside-air flow in a few rooms. I hope that, even if these trials are not successful, effective steps will be taken soon to solve a problem which has already lasted far too long.

A. Shupe: I don't have nearly as formal a presentation as we just heard, but late last semester I came to my office one day and there was a kind of sickly-sweet perfume smell. I asked the secretary to call maintenance to find out if somebody had shampooed the rug, or what; and the answer we got was that one of the maintenance people probably had been smoking, and this was an attempt to clean the air. My gripe is, if I can't smoke in my office I don't think anyone else should be able to.
