- 1. <u>Call to order:</u> F. Kirchhoff called the meeting to order at 12:09 p.m.
- 2. <u>Approval of the minutes of April 12, 1993</u>: The minutes were approved as distributed.
- 3. Acceptance of the agenda:

- 4. Reports of the Speakers of the Faculties:
 - a. Indiana University:

S. Hollander: I received an original and a revised version of President Ehrlich's university goals for the year. There are four major goals: number four is "search for and select a new president." Those of you who have read your e-mail know that I have been asked this morning to supply names for a search and screen committee by tomorrow. I will attempt to stall. If it is not possible to have an election, I will submit whatever names come to me over e-mail today. If you are interested and are faculty, send me your name or contact me after the meeting and I'll put you on the list.

Number two of those goals relates to teaching. It reads, "Reward teaching excellence and enhance teaching effectiveness using 1992 benchmarks; increase teaching and other faculty efforts over a three-year period with campus-specific goals." Under "Administration," they hope to maintain salary increases at least at the average rate of inflation. Faculty are singled out as the only group where productivity is to be examined.

I have been notified that because of budgetary constraints the number of copies of the IU Newspaper sent to this campus is being reduced. It may break your heart, but, especially if you are of the Purdue persuasion, you are not likely to get your own copy of the 1U Newspaper anymore. Copies, of course, will be on reserve in the library.

b. <u>Purdue University</u>:

R. Barrett: I have no report except to say that the first meeting of the Intercampus Faculty Council is this Wednesday.

F. Kirchhoff: I want to announce Mitch Sherr as Parliamentarian and Jeff Wilson as Sergeant-at-Arms.

9. The general good and welfare of the University:

M. Downs: I raise this point because it was called to my attention by a faculty member who does a good deal of his work in Walb Union. After he called it to my attention, I started noticing, too, the number of young children in the evening who are in the hallways and facilities unattended. I know the reason for this. It is because we no longer provide child-care on campus, and people whose baby-sitters fail them at the last minute quite often are forced to bring their children to school with them. It is not uncommon at all to walk down the hallway in CM and find two or three or four small children occupied with games, toys and so forth outside of classrooms. I

don't have any objection to that, but I think that the university ought to be concerned about possible liability if something were to happen. In Walb Union the problem is greater because, with open stairways and far fewer people around at that time, there is a possibility of injury. That was what prompted the faculty member to bring this to my attention. I would like to ask, if it is possible, that at an early meeting of the Senate we get a short report from Vice Chancellor Borelli on the ways and means and possibilities of restoring something like adequate child-care for students on this campus. This is not a motion. It is just a request that is connected in some way to the good and welfare of the university.

- R. Hess: It has come to my attention that possibly one of the items discussed at the Purdue University Board of Trustees last Friday was an issue concerning cashability of CREF for Purdue employees. Is that correct?
- J. Lantz: That is not correct. I was there the entire time and it was never discussed. I will say the presiding officer of the West Lafayette Senate did ask that the trustees make a decision about that.
- R. Hess: Do we have a salary for Purdue University employees?
- J. Lantz: They should be in the mail today or tomorrow....
- 10. Memorial resolution: Clifford A. Nault. Jr. (Senate Reference No. 93-2):
 - J. Brennan read the memorial resolution in memory of Clifford A. Nault, Jr. A moment of silence was observed.
