- 1. Call to order: J. Wilson called the meeting to order at 12:02 p.m.
- 2. <u>Approval of the minutes of April 13, and 20, 1998</u>: The minutes were approved as distributed.
- 3. Acceptance of the agenda:

- 4. Reports of the Speakers of the Faculties:
 - J. Wilson left the chair to make his report.
 - a. Purdue University:
 - J. Wilson: I have three major items to bring to your attention:
 - 1) Following discussions involving the Chancellor, Carolyn Jones, who is the Assistant Vice President for Academic Affairs at West Lafayette, and several

concerned IPFW faculty over the course of the summer, it is becoming clear--to me anyway--that West Lafayette administration will consider no changes to Executive Memorandum C-19. If we are going to have a grievance policy, it is going to have to work within C-19 or our aggrieved faculty will have no recourse recognized by the administration. On today's agenda is a resolution addressing this matter.

- 2) The Intercampus Faculty Council met to discuss two changes that have been approved by the University Senate at West Lafayette. That body has approved a plus/minus grading system for implementation in the fall of the year 2000. They have also approved a change to the incomplete grade. The most important ramification of that change is that following a period of three years of nonenrollment, an "I" becomes permanent. I believe these are good changes and have requested the Educational Policy Committee to take action to adopt these changes for this campus.
- 3) With regard to Purdue medical insurance, at a Purdue University Board of Trustees meeting this month the insurance package for the 1999-2000 year was approved. Premiums for the Purdue Health Plan will not change, but the contribution by Purdue to the Flexible Spending Accounts will be reduced to \$100.00. Participants opting for the Physicians Health Plan will see an 11% increase in their premiums, a 20% co-payment for out-patient services and a 20% co-payment for in-patient services. Out-of-pocket maximums will be capped at \$1000.00 per individual and \$2000.00 per family.
- 4) Finally, I was allowed three minutes to provide a report to the Board about IPFW. That <u>report</u> is available on my speaker's web page for those who might be interested in what I had to say.
- b. <u>Indiana University</u>: M. Downs had no report.

10. The general good and welfare of the University:

M. Downs: First of all I would like to congratulate the administration on the completion and opening of the new parking facility on campus. Having done so, I would like to call their attention to the continued existence of the "temporary" eyesore between the campus and river, the temporary parking lot for more years than many of us temporary human beings have been here. I think the time has come for that parking lot to be restored to its original purpose, which is aesthetic. I have heard from administrators that people are reluctant to park in the new parking garage. Taking the temporary parking lot out of production will create additional incentives for people to use the parking garage. The administration and the faculty have agreed that that parking lot was temporary and it is time to make that true.

I also request that the Presiding Officer, whomever that may be, ask Jack Dahl for an update on the motion which was passed by this body two years ago which expressed the sense that it would be a good idea if high-level administrators from time to time would go back to the classroom and teach a course. Has the amount of teaching done by higher administrators increased during this period? Once we have the answer in hand we may wish to go back to rescind or reassert the sense of the Senate in regard to this matter.

- J. Wilson: I'll see that the Presiding Officer takes that action.
- D. Weakley: This is a plea for volunteers to serve on the Senate Nominations and Elections Committee. Due to a resignation and a full-year sabbatical, the committee is now down to two: myself and Yvonne Zubovic, both from mathematical sciences. That's not exactly balanced and it is not very large. It is my understanding that the rules require that no more than two people from Arts and Sciences can serve. So if you are not from Arts and Sciences and you are a Senator and you would like to do this, please email or notify Barb Blauvelt by 5:00 tomorrow.
- M. Nusbaumer: I would like to express my concern about what I would now define as the infamous Fenwick English exit letter that was made available to the public press this summer. Two things trouble me: that apparently President Beering released such a letter widely to the public and the way this has been handled without

any effort to investigate the accuracy of the allegations. According to a recent *Journal-Gazette* article citing Chancellor Wartell, it was defined as an exit letter and it is not the position of the University. It is my understanding that this University has been conducting exit interviews with a variety of people leaving this campus for a rather long period and none of those was released or made public. It seriously draws into question the good faith relationship between Purdue administration and this faculty.

S. Hollander: The Budgetary Affairs Subcommittee has been among the busiest, most active, and, I think, most productive bodies of the Senate. During the summer they held a news conference for reasons which they believe to be fully adequate, including some time pressure to urge the state legislature and the Commission for Higher Education to take certain actions toward adequate funding for this campus. I would hope that in the future we would be very careful in scheduling news conferences by Senate committees and subcommittees rather than by bodies commissioned to do so by the Senate. It is very difficult for the public to be aware of who is speaking for "the faculty" and who is speaking for a smaller representative group of faculty.

M. Wartell: If I may I would like to hand out the newest version of U.S. News and World Report: Best Colleges for 1999. Jack Dahl has a copy of it. Of course, if anyone wants to, you can buy your own. What I have taken the liberty of doing is listing all of the colleges from Indiana that are listed there and all of the information about them; we have good reason to take pride in a certain number of the indicators there. First, our academic reputation, while it is sometimes a little bit like comparing apples and oranges, is third best to Bloomington, West Lafavette, and IUPUI. We are far ahead of Indiana State and Ball State. They are in different categories, but still it is some measure of reputation. The second area I think we have a good deal to be proud of is our SAT. The third area is the percent of full-time faculty. The fourth area, which we have no right to be proud of but does have an explanation, is our 42% freshman retention rate as compared to retention rates in the 60s for most of our colleagues. That is because we are forced to play by different rules. We are NCAA Division II so that when we look at retention rates we are forced to say full-time students fall to full-time students the next fall. The other institutions mix full-time and part-time. So, for example, a student starts at IPFW full-time one fall and becomes part-time the following fall, that student is not counted as a continuing student in our institution; it is in the other regional institutions in the state. There is a great deal of interesting data here. Most of it presents IPFW in a very favorable light and the faculty deserves a great deal of credit for the academic reputation of the institution.

Also, let me echo the chair's point about the opening of the Science Building tomorrow. I hope you will all be able to come out.
