Under certain circumstances, the Department of Education permits Purdue University Fort Wayne (PFW) to update information on the student's FAFSA to recalculate their eligibility for grants. The unwillingness of your parent(s) to provide parental data on your FAFSA or to help pay for college is NOT an acceptable reason to appeal your dependency status. If you already have a bachelor's degree, you are NOT eligible to appeal as you are ineligible for grants. ***If updates will not help you in any way, your appeal will be denied.***

### Please submit the following with this cover letter

*(Incomplete appeals will not be processed)*

- ☐ Signed, and dated (legible) personal statement including an explanation and any vital information that will help us understand your situation – You must include start and end dates (at least month and year) for all pertinent information
- ☐ Two signed and dated letters of support (on letterhead) from objective third parties documenting their knowledge of your specific situation
- ☐ Additional documentation as required under the chosen appeal type
- ☐ Completed verification form and documentation (if selected)

### Appeal Type Selection

- ☐ Orphan, Ward of Court, Foster Care, Emancipated Minor, Legal Guardianship
  - Copy of official federal, state, and/or local legal document(s) detailing the determination
- ☐ Unaccompanied and either homeless or self-supporting and at risk of being homeless

- ☐ Death of custodial parent(s)
  - Copy of death certificate(s)
  - Student birth certificate
