## Work from Home Policy Statement

Over the summer, CSSAC partnered with APSAC to collect staff feedback on the change in work from home policies and deliver a formal statement to the Chancellor.

### The Survey

Thank you to everyone who responded to the survey! From 241 responses, we received a lot of information about PFW staff's experience with remote work—including 27 pages of written feedback on the policy change. The overwhelming response was that staff were not happy with this change, but there were also some legitimate issues with remote work raised.

### The Results

CSSAC and APSAC jointly developed a memo regarding the policy change and providing recommendations for leadership to better support staff in this decision. CSSAC and APSAC leadership sent this memo to the Chancellor on June 18, 2025. As of the publication of this newsletter, we have not heard any response from the Chancellor or other university leadership.

## Resource Highlight: Low-Sensory Spaces

The Division of Campus and Community Wellbeing provides low-sensory spaces on campus to help you decrease anxiety and stress. These rooms have low lights, white noise, comfortable chairs, and relaxation tools like coloring supplies, sand trays, and weighted blankets.

There are two low-sensory spaces on campus:

- In the Center for Student Counseling in KT G02 (the Mastodon Relaxation Zone)
- In the Disability Access Center in Walb 113

## Benefit Breakdown: Archimedes

Higher cost medications that require special handling, monitoring or administration are known as Specialty Medications. These medications require prior authorization to be filled and are ordered through a specialty pharmacy. Archimedes is the administrator of Purdue's specialty medications, and they work with AcariaHealth as their pharmacy provider.

Archimedes finds ways to help you save money on the cost of your specialty medications. Sometimes, there are copay assistance programs and discounts available from the drug's manufacturer that will help cover the cost of the medication. Archimedes will find these opportunities and work with you to ensure that you get your medication at the best rate possible.
